Executive Summary

CHNA Purpose Statement

The purpose of this community health needs assessment (CHNA) is to identify and prioritize significant health needs of the community served by CHI Health Missouri Valley. The priorities identified in this report help to guide the hospital's community health improvement programs and community benefit activities, as well as its collaborative efforts with other organizations that share a mission to improve health. This CHNA report meets requirements of the Patient Protection and Affordable Care Act that not-for-profit hospitals conduct a community health needs assessment at least once every three years.

CHI Health is a regional health network consisting of 28 hospitals and two stand-alone behavioral health facilities in Nebraska, North Dakota, Minnesota and Western Iowa. Our mission calls us to create healthier communities and we know that the health of a community is impacted beyond the services provided within our wall. This is why we are compelled, beyond providing excellent health care, to work with neighbors, leaders and partner organizations to improve community health. The following community health needs assessment (CHNA) was completed with our community partners and residents in order to ensure we identify the top health needs impacting our community, leverage resources to improve these health needs, and drive impactful work through evidence-informed strategies.

CHI Health Missouri Valley Overview

CHI Health Missouri Valley is a community-based critical access hospital with 25 acute inpatient beds. The community-based hospital offers many forms of care: technologically advanced medical services, quality health education, health screenings and more. In 2021, CHI Health Missouri Valley received a five star rating from the Centers for Medicare & Medicaid Services (CMS) on its Overall Hospital Quality Ratings for 2021.

Community Definition




Figure 1. CHI Health Missouri Valley Service Area - Harrison County, Iowa

CHI Health Missouri Valley is a Critical Access Hospital located in Missouri Valley, IA and



largely serves the Harrison County area. As a Critical Access Hospital, CHI Health Missouri Valley's primary service area is considered the county in which they are located, Harrison County, which includes the following zip codes: 51555, 51546, 51579. See figure 1 below.

Assessment Process and Methods

CHI Health Missouri Valley engaged in the CHNA process led by HCHPH which included the collection of primary and secondary data. Primary data was collected through a community survey and a key informant survey. HCHPH sourced secondary data on a range of community health indicators, including, but not limited to: population demographics, socioeconomic factors, health status (including chronic disease and poor mental health prevalence) and health outcomes (mortality). Community health data was analyzed to discern variation from benchmarks (including comparison to peer counties, the State and U.S.), identify notable multi- year trends in the data and account for frequency of the issue being cited as a significant health need by community stakeholders.

Process and Criteria to Identify and Prioritize Significant Health Needs

Healthy Harrison Coalition

Harrison County Home and Public Health Department convened individuals from organizations representing CHI Health Missouri Valley, public health, aging, disability, mental health, low income and education, through an established collective impact organization, *Healthy Harrison Coalition (HHC)*. Participants sponsoring organizations are listed above in "Community Health Needs Assessment Process and Methods." Through a series of monthly meetings from December 2021- February 2022, coalition members reviewed primary and secondary data on a variety of community health indicators. All parties who reviewed the data found the data to accurately represent the needs of the community.



On February 8th 2022, Healthy Harrison Coalition members were asked to vote on the top health needs for Harrison County using the following criteria:

- severity of the health issue
- population impacted (making special consideration to disparities and vulnerable populations)
- trends in the data
- existing partnerships
- available resources
- hospital's level of expertise
- existing initiatives (or lack thereof)
- potential for impact
- community's interest in the hospital engaging in that health area

Prioritized Significant Health Needs

- Behavioral Health (includes Mental Health and Substance Abuse): 2,340:1 mental health
 provider ratio in Harrison County, significantly higher than the state overall at 1,450:1. 25.45%
 of community survey respondents identified "mental health problems" as one of the the three
 most important health concerns in Harrison County. 44.08% of community survey respondents
 identified "alcohol/drug use" as one of the the 3 most important health concerns in Harrison
 County.
- Health Related Social Needs (includes food access and may address housing and/or transportation): 16.28% cost burden households in Harrison County (housing costs exceed 30% of household income). 15% of community survey respondents identified "housing that is safe and affordable" as one of the 3 most important health concerns in Harrison County.

Resources Potentially Available

In addition to the services provided by CHI Health Missouri Valley, there are assets and resources working to address the identified significant health needs in Harrison County. Harrison County has a number of community assets and resources that are potentially available to address significant health needs. In terms of physical assets and features the communities have parks including Summit Park and Little Willow Park. Communities also have recreation facilities including an aquatic center and museums.

Introduction

Hospital Description

CHI Health Missouri Valley is a community-based hospital in Missouri Valley, Iowa, and primarily serves the rural area of Harrison County, located in the Loess Hills, near the Missouri River. The community-based hospital offers many forms of care: technologically advanced medical services, quality health education, health screenings and more. Beyond the hospital walls, CHI Health Missouri Valley works closely with businesses, community groups, churches, schools, social service agencies, and others to build a healthier community. In 2021, CHI Health Missouri Valley received a five star rating from the Centers for Medicare & Medicaid Services (CMS) on its Overall Hospital Quality Ratings for 2021.

- 4. Ensure compliance with section 501(r) of the Internal Revenue Code for not-for-profit hospitals under the requirements of the Affordable Care Act.


Community Definition

CHI Health Missouri Valley is a Critical Access Hospital located in Missouri Valley, IA and largely serves the Harrison County area. As a Critical Access Hospital, CHI Health Missouri Valley's primary service area is considered the county in which they are located, Harrison County, which includes the following zip codes: 51555, 51546, 51579. Community Description

CHI Health Missouri Valley is located in Missouri Valley, Iowa. Missouri Valley is in the southwest corner of Harrison County, a non-metropolitan county located in west central Iowa. Harrison County is composed of nine school districts and ten incorporated towns: Dunlap, Little Sioux, Logan, Magnolia, Missouri Valley, Modale, Mondamin, Persia, Pisgah and Woodbine. Logan is the county seat and there are also six unincorporated towns, and 20 townships.¹

Population

According to the most recent census estimates, Harrison County is 81% rural, encompasses 697 square miles and has 14,582 residents. The population density of Harrison County is estimated at 21.4 persons per square mile, making it less than half as densely populated as the state of lowa (54.5 persons per square mile). The population of Harrison County is primarily non-Hispanic White, and a slightly higher percentage of residents over 65 years of age reside in Harrison County (19.9%), compared to the State of lowa (17.5%). Socioeconomic Factors

Table 2 shows key socioeconomic factors known to influence health including household income, poverty, unemployment rates and educational attainment for the community served by CHI Health Missouri Valley. The median income in Harrison County (\$63,854) is slightly higher than the state average (\$60,523). Harrison County has a similar percentage of high school graduates rates, compared with the State of Iowa (Harrison County: 94.1, Iowa: 91.4), but educational attainment is lower in Harrison County with regard to completion of a Bachelor's degree (Harrison County: 19.46%, Iowa: 28.57%).

Health Professional Shortage Areas (HPSA) and Medically Underserved Areas (MUA)

Harrison County has 13 designated Health Professional Shortage Areas (HPSA) including primary care, dental health, mental health disciplines. The HPSA scores range from 7 to 17 (12.77 median score) where the score range is 0 to 26 (the higher the score indicates a greater priority). Harrison county has two designated Medically Underserved with scores of 61.8 and 60.9 where the lowest score (highest need) is 0; the highest score (lowest need) is 100.9,10

Community Needs Index (CNI)

One tool used to assess health need is the Community Need Index (CNI). The CNI analyzes data at the zip code level on five factors known to contribute or be barriers to healthcare access: income, culture/language, education, housing status, and insurance coverage. Scores from 1.0 (lowest barriers) to 5.0 (highest barriers) for each factor are averaged to calculate a CNI score for each zip code in the community. Research has shown that communities with the highest CNI scores experience twice the rate of hospital admissions for ambulatory care sensitive conditions as those with the lowest scores.

Harrison County CNI scores that have a weighted average CNI score of 2.3 and a median score of 2. The scores range from 1.4 to 3. Three zip codes in Harrison County (51545, 51555, 51564) have the highest CNI scores ranging from 2.8 - 3. The total population in these zip codes is 5,717. A higher CNI score in these zip codes suggest residents may experience greater barriers accessing care and/or require more healthcare services than peers in zip codes with lower CNI scores. 

Unique Community Characteristics

Harrison County is primarily rural in nature with manufacturing and agriculture being the major industries. Local businesses such as Tommy Gate, Carry-On Trailer, and E4 Precision Ag provide steady job opportunities and bring resources to the communities. A stable county government as well as strong support from Iowa State University Extension services also maximizes resources in the county. Missouri Valley is situated less than a mile east of Interstate 29 and less than five miles north of Interstate 80.

Other Health Services

CHI Health Missouri Valley is the only hospital located in Harrison County. CHI Health Missouri Valley works with Harrison County Home and Public Health (HCHPH) to collaborate in identifying and addressing community health needs. Formed in 2013 in response to the Community Health Needs Assessment, both entities stepped up to co-lead the Healthy Harrison Coalition (HHC), with the mutual goal of improving health in Harrison County through shared vision and collaboration. CHI Health Missouri Valley also has a network of highly skilled and specialty care physicians with clinics located in Dunlap, Logan, Missouri Valley, Oakland and Woodbine. Health systems in the area are listed below and a full list of resources within the community can be found in the "Resource Inventory".



Community Health Needs Assessment Process and Methods

Harrison County Home & Public Health Department (HCHPHD) partners with state public health, policymakers, health care providers, business and many others to fulfill its mission to promote physical and mental health and prevent disease, injury, and disability for the residents of Harrison County, IA.

In order to assess the health needs across the county, HCHPH implemented a Community Health Survey and Key Informant Survey. Results of the Community Health Survey and secondary data analysis were presented to a group of stakeholders at a Healthy Harrison Coalition Meeting.

HCHPH analyzed secondary data on a range of community health indicators, including, but not limited to: population demographics, socioeconomic factors, health status (including chronic disease and poor mental health prevalence) and health outcomes (mortality). Community health data was analyzed to discern variation from benchmarks (including comparison to peer counties, the State and U.S.), identify notable multi- year trends in the data and account for frequency of the issue being cited as a significant health need by community stakeholders. Community Health Survey

HCHPHD conducted a Community Health Survey from July 2021 to August 20, 2021. Community members were able to complete the survey electronically which resulted in over 600 reponses. Full results can be found in Appendix A.

Stakeholders were invited to complete an online Key Informant Survey, with a total of 23 respondents. Rull Results can be seen in Appendix B.

Healthy Harrison Coalition Meeting

Strong community involvement is a critical element of the CHNA process. Community input was gathered through the Healthy Harrison Coalition, co-led by CHI Health Missouri Valley and Harrison County Home and Public Health Department. On February 8th 2022, the Healthy Harrison Coalition hosted a Community Health Needs Assessment data presentation facilitated by HCHPHD. The objectives of the meeting were to review community health data, engage in a facilitated discussion to validate the top health needs for Harrison County, and brainstorm potential strategies and partnerships to impact



the top health needs over the next three- year implementation strategy plan (ISP), beginning July 1, 2022 and concluding June 30, 2025.

Stakeholders attending the Healthy Harrison Coalition February 8th meeting represented those who serve **minority**, **at-risk**, **uninsured**, and **aging populations**, as well as **those affected by violence**. A total of 18 stakeholders participated representing the following organizations:

Gaps in information

Although the CHNA is quite comprehensive, it is not possible to measure all aspects of the community's health, nor can we represent all interests of the population. Challenges exist in both counties around reliable data collection due to small sample sizes among different populations and indicators. This assessment was designed to represent a comprehensive and broad look at the health of the overall community. During specific hospital implementation planning, gaps in information will be considered and other data and input will be sought as needed.



CHI Health Missouri Valley invited written comments on the most recent CHNA report and Implementation Strategy both in the documents and on the website where they are widely available to the public. No written comments have been received

Prioritized Health Needs

After reflecting on the data presented, the 22 HHC participants voted on the top community health needs for Harrison County:

- 1. Behavioral Health (Mental Health and Substance Abuse): 2,340:1 mental health provider ratio in Harrison County, significantly higher than the state overall at 1,450:1. 25.45% of community survey respondents identified "mental health problems" as one of the three most important health concerns in Harrison County. 44.08% of community survey respondents identified "alcohol/drug use" as one of the the 3 most important health concerns in Harrison County. Further, aging issues may be addressed within this priority.
- 2. Health Related Social Needs (e.g. food access, housing and/or transportation): 16.28% cost burden households in Harrison County (housing costs exceed 30% of household income). 15% of community survey respondents identified "housing that is safe and affordable" as one of the 3 most important health concerns in Harrison County. Strategies to address drivers of obesity may also be considered, as well as focus populations, including aging older aduls.

2.2. Partner with CHI Health clinics to improve continuum of care for patients with positive depression screening

Results

FY20 Key Activities

- This process was informed by the Healthy Harrison Coalition membership, which includes CHI Health Psychiatric Associates, Southwest Iowa Mental and Disabilities Services Region, Crossroads Office on Aging and local school districts to name a few. Beginning in the spring 2020, Healthy Harrison Coalition hosted weekly calls with community partners and mental health providers to understand needs/ care gaps.

Planned efforts in FY21 include: billing Medicare and Medicaid for depression screening (using CMS metric detailed below) and using revenue from Medicare/ Medicaid reimbursement to cover Integrated Behavioral staff to split time between clinics located in Harrison County.






Q2 In the past 30 days have you been concerned about having enough food for you or your family?

Q3 Exposure to the following items in or around households has been associated with poor health. Which of the following do you think have threatened you or your family's health in the past year? (Mark all that apply)







Q5 What do you think are the 3 greatest STRENGTHS of Harrison County? (Select only three answers)







Q12 Which additional mental health services do you feel Harrison County should have?

















Behavioral Health- ED visits








Mortality- Harrison County and Iowa




Q2 In the past 30 days have you been concerned about having enough food for you or your family?

Q4 Do you identify as an individual with a physical or mental disability that limits your movement, senses, or activity? If so, which disability do you associate with? (Mark all that apply)



Q5 What do you think are the 3 greatest STRENGTHS of Harrison County? (Select only three answers)








Q6 What do you think are the 3 most important health concerns in Harrison County? (select only three answers)








Q9 If Harrison County received \$1 million dollars what do you feel the money should be designated towards? (select up to three answers)


Q10 Which of the following preventative procedures have you had in the past 12 months?




Q12 Which additional mental health services do you feel Harrison County should have?

Q23 What has prevented you from seeing a doctor when you were sick, injured, or needed some type of health care? (Mark all that apply)




