#### **CHI Health Immanuel**

CHI Health is part of CommonSpirit Health, a nonprofit, Catholic health system dedicated to advancing health for all people. Located in North Omaha just off of I-680 on 72nd Street, CHI Health Immanuel is a full-service hospital, Cancer Center, Rehabilitation Institute and Specialty Spine Hospital. The hospital's rather geographically isolated location within the metro area contributes to its steady medical and behavioral emergency department censuses. As a part of our organization's Neurological Institute, Immanuel has been designated a Level 4 (highest level) Epilepsy Center and has achieved certification as an Advanced Thrombectomy Capable Center.

Immanuel has a teaching and research affiliation with Creighton University School of Pharmacy and Health Professions. Decentralized clinical pharmacists are available to all care units and serve as an integral part of the healthcare team. Clinical pharmacy functions include pharmacokinetic and pharmacotherapy monitoring and dosing, multidisciplinary care team rounding, antimicrobial stewardship, anticoagulation monitoring and management and drug information.

The residency program at Immanuel is designed to develop a practitioner with expertise in the provision of pharmaceutical care that centers on development of knowledge and skills needed to become a competent and confident practitioner. The resident will be accountable for optimizing drug therapy and achieving the most favorable outcomes as a member of the CHI Health care team. The resident will provide drug information and education to patients, other healthcare professionals and students. The residency is flexible and provides the resident with a wide range of experiences.

## **Qualifications of Applicant**

- 1. The candidate must possess a Doctor of Pharmacy degree awarded from an ACPE-accredited College of Pharmacy.
- 2. The candidate must be eligible for licensure as a pharmacist in Nebraska.
- 3. Membership in the American Society of Health-System Pharmacists is required.
- 4. To be considered for an onsite interview. the candidate must apply via the PhORCAS online application system by the listed deadline. The list of application materials may be found within the PhORCAS online application, and will include the standard PhORCAS application, a Curriculum Vitae, pharmacy college transcripts, and three letters of reference.

# **Purpose Statement**

The purpose of the Postgraduate Year One (PGY1) Pharmacy Practice Residency Program is to provide organized and directed pharmacy training in a community hospital setting. The program develops the knowledge and skills of the resident in various areas including: medication therapy management, communication, practice management, critical thinking, time management, clinical research, drug information and teaching. The program offers the resident the opportunity and stimulus to develop, to the highest degree obtainable, his/her professional expertise as a practitioner. Graduates of this program will be highly qualified to practice as pharmacist clinicians in patient care positions, adjunct faculty positions, or for PGY2 training in their area of choice.

#### Structure

CHI Health Immanuel residency is a one-year program consisting of 12 one-month blocks. The schedule offers rotations in core areas of patient care while allowing the resident up to three months of elective rotations. The program is structured to provide the resident with diverse experiences in the provision of direct patient care and achievement of residency goals including medication therapy management.

## **Required Rotations Include:**

- · Orientation & Training
- Adult Medicine
- Adult Medicine 2
- Adult Psychiatry
- · Critical Care
- Infectious Diseases
- Management
- · Rehabilitation Medicine

## **Required Longitudinal Rotations Include:**

- Residency Project and Drug Information
- Staffing

#### **Elective Rotations Offered:**

- Critical Care 2
- Emergency Medicine
- Nephrology
- Neurology
- Psychiatry 2
- Surgery

Required rotations may be repeated if desired.

## **Residency Opportunities**

- Provision of drug information related to patient care and prospective therapeutic drug monitoring to ensure provision of safe, efficacious, and cost-effective pharmacotherapy to patients.
- Decentralized clinical pharmacy service: Medical/Surgical, Adult ICU, Hematology/ Oncology, Psychiatry, Peri- and Postoperative Care, Medical and Behavioral Emergency Medicine and Multidisciplinary Care Team Rounds.
- 3. Staffing as a clinical pharmacist in the Inpatient Pharmacy.
- 4. The resident is required to prepare and present two grand rounds presentations. Other teaching opportunities, if interested, include staff education, didactic lectures, assisting with Pharmacotherapeutics Cases Studies for P2 and P3 students and precepting PharmD students on clinical rotations. The resident also has the opportunity to complete the teaching certificate program offered through Creighton University.

# **Stipend and Benefits**

The Postgraduate Year One (PGY1) Pharmacy Practice Residency Program at Immanuel offers a competitive stipend. Additional benefits include paid vacation/sick time, medical insurance plans, and financial support to attend the American Society of Health-System Pharmacists Midyear Clinical Meeting.
